



DESCRIPTIONS

Our 150W switching power supply is a AC to DC switching power transfer device which can provide a 12V, 12.5A max & 150W maximum DC output with constant voltage source. It comes with high efficiency, stability and almost all kinds of circuit protections, resulting in the long life time. When being input with full load, the maximum input current is 0.9A @ 220V and 1.8A @ 110V respectively.

When the output voltage reaches 150% of the rated voltage, the over voltage protection will works to shutdown and latch the output.

When the output current reaches 110 ~ 150% of the rated output current, the over current protection will works, and the modules will not enter into normal condition till the fault condition is removed.

Our switching power supply comes in a weight of 820g, and a size of 171mm(L) x 71mm(W) x 40mm(H), and a DC plug size of 5.5mm x 2.1mm x 12mm.

Our seitching power meets the UL, CUL, TUV/GS, CE, FCC, CB, PSE, CCC and the CEC Level IV requirement well.

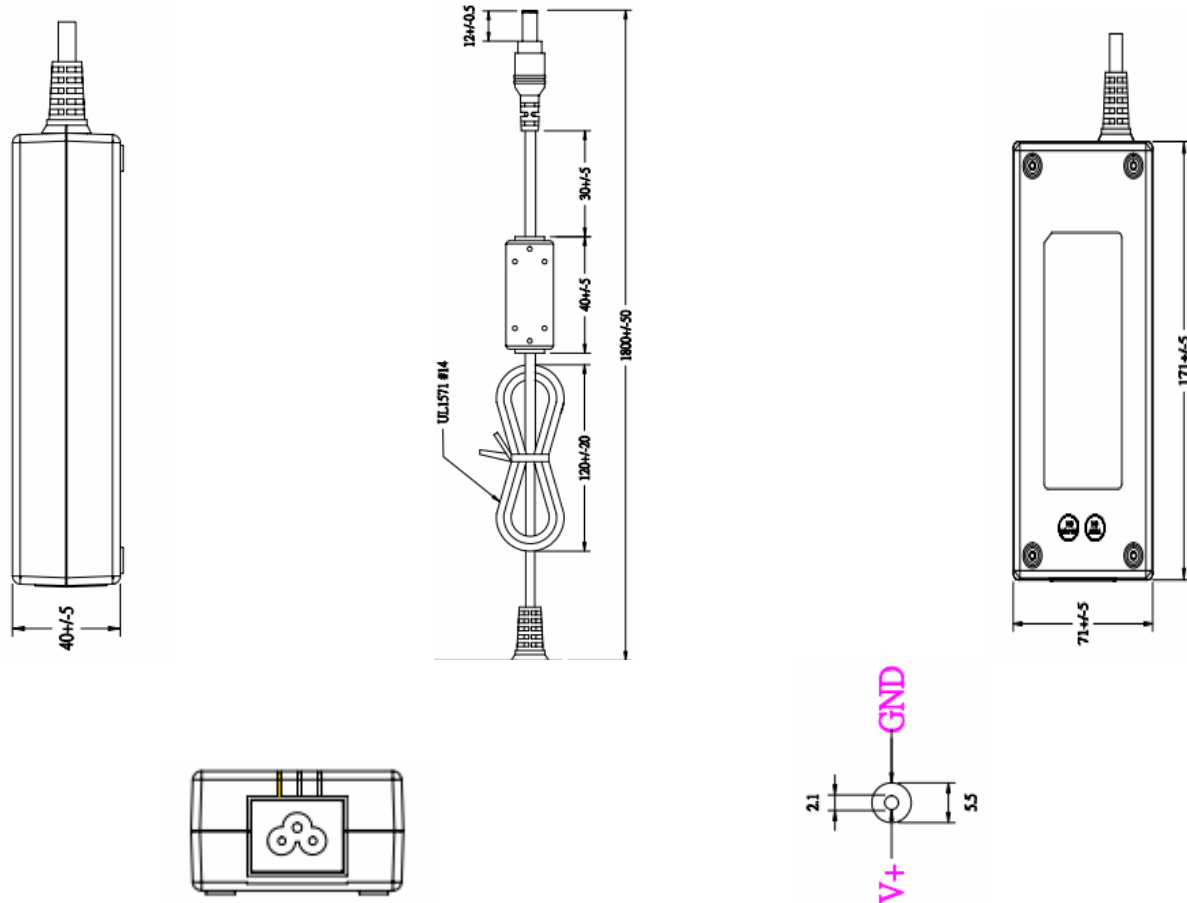


Figure 4. Mechanical Dimensions
